RBA Commitee receives comments from Chesterfield judges

In its continued effort to promote the administration of justice in the Richmond area and to facilitate cooperation between the bench and the bar, the Bar's Administration of Justice Committee recently concluded its annual interviews with the Honorable Judges for Chesterfield County. As in years past, the Judges were gracious with their time and spoke with candor to Committee members regarding the Court's work and the performance of the bar in their courtrooms.

Hon. Steven C. McCallum, Chesterfield County Circuit Court

Judge McCallum appreciates the collegiality and professionalism of the bar. There have been significant changes in the court this year. For the first time in history, the Chesterfield Circuit Court has six full time sitting judges. The timing of the appointment of new judges has become difficult to predict. For example, the appointment of the three new judges for Chesterfield Circuit Court was made effective December 1, 2014. The new judges are Judge Edward A. Robbins, Jr., Judge Lynn S. Brice, and Judge David E. Johnson.

The Chesterfield courthouse has only five Circuit Court judge's chambers and courtrooms, making the expansion to six judges

a logistical challenge. To accommodate the additions, the court has converted a library into a judge's chamber and is utilizing the 1917 Courthouse, which was renovated a few years ago as a venue for hearing civil cases on Wednesdays, Thursdays, and Fridays when needed. Generally, Judge Robbins sits in the Circuit Court of Colonial Heights on Mondays and Tuesdays, therefore an additional courtroom is not needed in Chesterfield on those days. The 1917 Courthouse cannot be used for criminal matters because it lacks holding space, but it is suitable for civil matters. Use of the historic Courthouse can present scheduling and logistical issues. Members of the bar should be aware that some of their civil cases may be set for the 1917 Courthouse on fairly short notice.

For efficiency purposes, the court encourages attorneys to preset their cases rather than waiting for docket call. Attorneys are expected to exchange dates. If an attorney fails to provide dates when repeatedly requested by opposing counsel, the court will set the case based on the schedule of the attorney requesting the hearing. The court may, in some instances, admonish unresponsive counsel that a date will be set without their input if counsel fails to provide dates within 48 hours.

Attorneys are encouraged to reserve the appropriate amount of time for their matters to be heard. If one party files a motion and reserves the appropriate amount of time for that motion, and another party wishes to be heard on the same day on additional motions, the other party should reserve the additional time or it may not be possible to hear the additional matter or matters that day.

Time management is a significant challenge for the court. It is helpful when attorneys realistically assess how much time is

needed for a hearing or trial and schedule the appropriate amount of time for all matters to be heard. When a case has to be heard partly on one day and partly on a much later date, it is more difficult for the judge to assess the credibility of witnesses heard on a distant date and weigh the evidence from date to date.

For divorce cases, there is no hard and fast rule about how much time the court will allow for an ore tenus hearing and various judges have preferences on whether evidence should come differing in by deposition or ore tenus hearing. The attorney seeking to set a trial date can discuss these matters with the judge's law clerk.

The court recognizes the need for a client to have his or her issues heard, but encourages the lawyers to organize their cases in such a way as to have the evidence at trial proceed efficiently. It is recommended that cases that are expected to last a full afternoon, be set at one o'clock and that the entire afternoon be reserved.

The court has revised its rules regarding cell phones in the courthouse. Lawyers may now bring cell phones and lap tops into the courthouse and can check available and avoid dates using these devices when setting hearing dates.

Judge McCallum stresses that the court seeks to operate efficiently and promptly and he appreciates the bar's effort to achieve this goal.

Hon. J. David Rigler, Chesterfield County Juvenile and Domestic Relations Court

Chief Judge J. David Rigler reports that overall the Chesterfield J&DR judges are pleased with the professionalism of the attorneys appearing before them. Attorneys are generally prepared, do a good job for their clients, and appear civil.

Judge Rigler notes that with the addition of a sixth judge the docketing has changed and now the judges rotate on a six week time table. Judge Rigler hopes that this process will allow the court to more efficiently hear cases.

Judge Rigler would like to remind attorneys that contested matters on the civil docket are set for a maximum of two hours. He reminds attorneys to focus their cases and to plan witnesses and evidence in a way that is helpful. Evidence that is presented should not be limited to one party's opinion and, ideally, should be supported by proof such as employment records, photographs, or other corroboration. A focused presentation of evidence allows the cases to be heard within the court-ordered time limits. Judge Rigler encourages attorneys, to the extent possible, to communicate with opposing counsel prior to any appearance before him regarding the areas of disagreement and to attempt to determine how much of a disagreement exists.

Judge Rigler reminds that attorneys should be prepared with factual and legal authority for their positions, even where they have appeared before the judge on multiple occasions on the same issue. Statements of opinion with no factual basis and statements providing rulings of other courts are not persuasive authority.

Additionally, Judge Rigler reminds the bar that the J&DR Court has a new clerk, Laura G. Griffin. Judge Rigler requests that the bar provide feedback regarding what the Court is doing well and how the Court can further appropriately serve the public.
